

# Hanyang Model United Nations IV

## Terms and Conditions

If this document is submitted to the HMUN Secretariat, it is regarded that the delegate has accepted the following terms and conditions.

### 1. Condition of Eligibility

1. All HMUN participants must be older than 13 years old and younger than 20 years Korean age or a university student status (no age limit). Exceptions can be made when he/she is attending middle or high school beyond the age range.
2. All participants not abiding by these terms may be labelled ineligible and subsequently disqualified from participation and may be denied application in future HMUN conferences by the Secretariat.

### 2. Committee and Delegation Assignment

1. All participants are responsible for accurately filling out personal information, preferred delegation, and preferred committee on all application documents. These are subject to the terms below:
  - i. One country is assigned to each delegate,
  - ii. Preferred delegation reflects personal preference but may be different according to application order and relevant experience,
  - iii. Preferred committee reflects personal preference but may be different according to application order and relevant experience.

### 3. Pledge of Participation

1. Pledge of Participation includes all terms participants must abide by before and during the conference. All participants must thoroughly read and **bring the signed document printed** on the first day to be registered.

3. Participation is only allowed under the following conditions:
  - i. “Pledge of Participation” is properly submitted,
  - ii. “Pledge of Participation” is completely printed,
  - iii. “Pledge of Participation” is properly signed by the participant.

### 4. Refund Policies

1. Refunds are available for participants no longer willing to participate in the conference.

3. Any forms submitted after November 27 23:59:59 will not be accepted.

#### 5. Attitude and Demeanor

1. For all participants of HMUN, discriminatory statements and/or actions regarding race, gender, sexual orientation, nationality, religion, age, disability, or appearance are strictly prohibited.
2. If such actions are seen by the Staff, Student Officers, or Secretariat, the Secretariat is eligible to take any of the following protocol:
  - i. Verbal caution,
  - ii. Disqualification from the conference with no refunds,
  - iii. Mark ineligible for future HMUN conferences and all associated events,
  - iv. Legal actions regarding the perpetrator and contact with associated group or legal agencies.
3. Participants must follow the following dress code:
  - i. All participants must wear formal,
  - ii. School uniform is allowed but not suggested,
  - iii. School uniforms that show the school logo are prohibited.
4. Any participants not in accordance with the dress code specified in the Code of Conduct may face consequences as the following:
  - i. Removal from award considerations,
  - ii. Disqualification from the certificate of participation.

#### 6. Exceptions and Violation

1. Office of Hanyang University School of International Studies and Secretary General of HMUN 4 have the authority to allow exception for the terms and conditions of the conference.
2. Any violation of the above terms, the Participant Code of Conduct, or Rules of Procedure will prohibit participation without refund.
3. Please be reminded that any severe infringement of these regulations will prohibit the participant from attending not only the conference but future HMUN conferences and any associated events.
